## **BRIEF RESEARCH STATEMENT**

My research examines health and well-being from two different perspectives. The first focuses on the association between religion and health. My published research in this area shows that

religious practices and beliefs (e.g., service attendance, prayer, a perceived attachment to God) provide social and psychological resources that promote health and well-being, in part by helping individuals cope with stressful conditions. I am currently working on projects linking religious involvement with physical health, psychological well-being, substance use, overall flourishing, and health-related character strengths and virtues including accountability, forgiveness, meaning, and purpose in life. My second research agenda examines the role of early-life social conditions (e.g., religion, childhood SES, parent-child relations, peer influences) in shaping trajectories of health that span adolescence and adulthood. I am currently working to identify salient early-life factors, as well as mediating variables that link childhood conditions with adult health. Overall, my research is helping to identify social and behavioral factors that can be targeted by healthcare professionals and policymakers to improve individual lives and population health. #### **BRIEF TEACHING STATEMENT**

My courses are designed to teach students about themselves and others in hopes of making them better citizens, employees/employers, spouses, parents, and children. In class, we discuss elemental questions such as: Why do people think and act the way they do? Is human behavior the product of nature or nurture? How do parents, peers, religious leaders, and other agents of socialization influence behavior? To what extent is human behavior shaped by gender, race, and SES? What are some social problems in the world today? My courses focus on critical thinking, not mindless regurgitation. To achieve this goal, I take an "active-learning" approach. I do not

lecture to students; instead, they contribute to an open exchange of ideas during class, and we work together as a team to understand course concepts. Students commonly say that my courses are interesting, unique, useful, and engaging, and that they learned a lot. They also say that I am a passionate and caring teacher. Peer assessments of my teaching are also positive, and I have received numerous teaching awards throughout my career. Outside the classroom, I have supervised numerous Ph.D. dissertations, M.A. theses, and undergraduate honor's theses. More than half of my publications include student coauthors.
